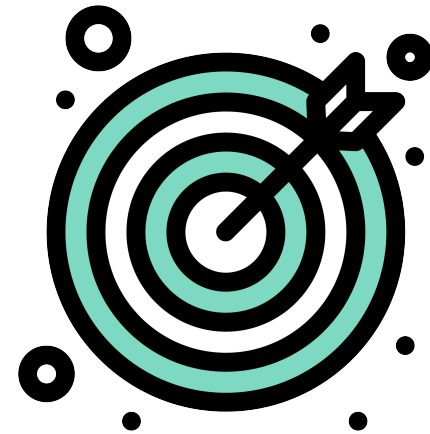

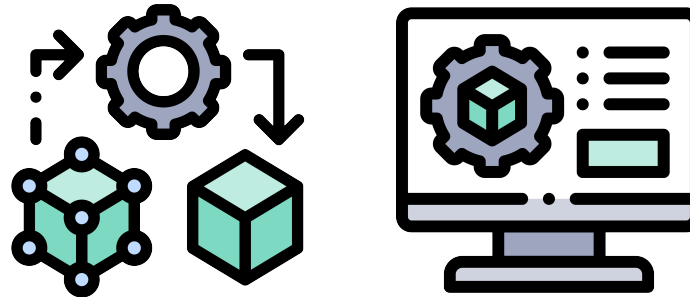
Background & Purpose

- To support the Canadian post-secondary research landscape, and to ensure it remains globally competitive, the Government of Canada has earmarked **\$572.5M over 5 years** toward a **national Digital Research Infrastructure (DRI) strategy**.
- Innovation, Science and Economic Development Canada (ISED) has set aside **up to \$375M** of the 5-year federal funding to establish a national not-for-profit organization: the **New Digital Research Infrastructure Organization (NDRIO)**.

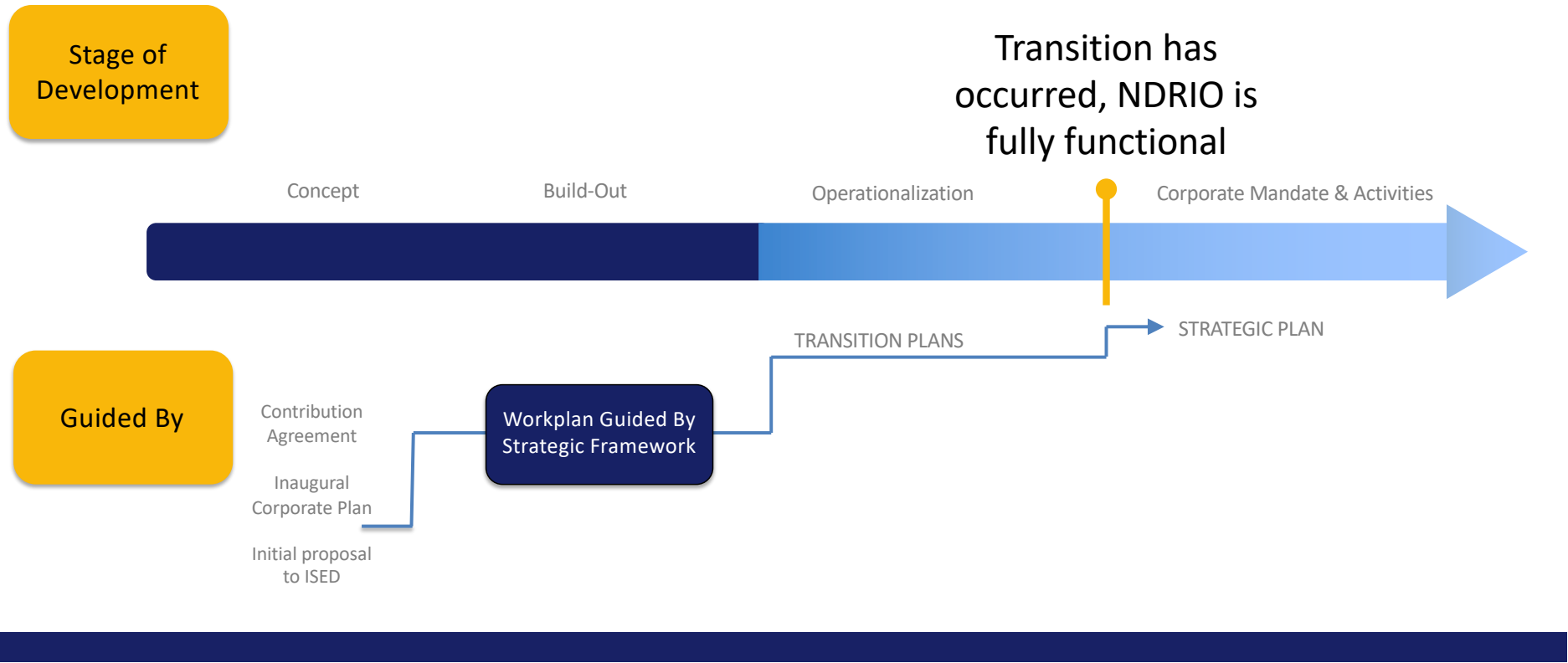


Background & Purpose

- NDRIO will coordinate funding and strategic directions for national DRI activities related to **advanced research computing (ARC), data management (DM), research software (RS) and cybersecurity within the DRI ecosystem**, working collaboratively with all stakeholders.
- CANARIE will continue to lead in the area of the Digital Network for Research & Education.



Guiding NDRIO from Concept to Enterprise



NDRIO Priorities 2020-21

Stream 1: Build the Organization

1. Finalize NDRIO's **governance, organizational structure and HR plan.**
2. Establish the **Researcher Council.**
3. Articulate the **strategic plan**, including a **national vision and strategy for growth in ARC, DM and RS**, based on current-state and user-needs assessments.
4. Establish **backroom finance and administrative functions, and management processes.**
5. Define the **NDRIO brand** and **establish communications mechanisms.**

NDRIO Priorities 2020-21

Stream 2: Build New Service Delivery and Funding Models

6. Build **new service delivery and funding models, in collaboration with regions, host sites and other DRI partners.**
7. Lead the **development and delivery of initial projects** (ARC – DM – RS).
8. Safeguard DRI resources through enhanced investments and coordination in **cybersecurity.**
9. Develop a **joint DRI Ecosystem Plan, working with CANARIE.**

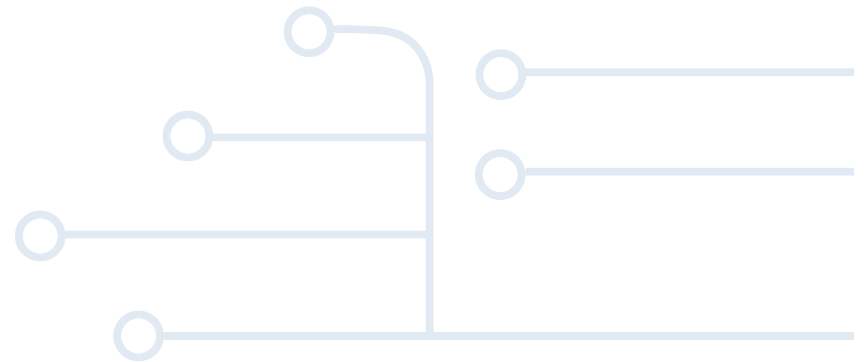
Stream 3: Plan Transition Activities

- 10. Develop transition plans (to be completed in 2021-22),** providing for continuity of service delivery and the assessment of existing Highly Qualified Personnel and infrastructure.

- 12. Lead development of a change management strategy and professional development plan.**
- 13. Complete the transition of DM – CARL Portage.**

Accomplishments to Date

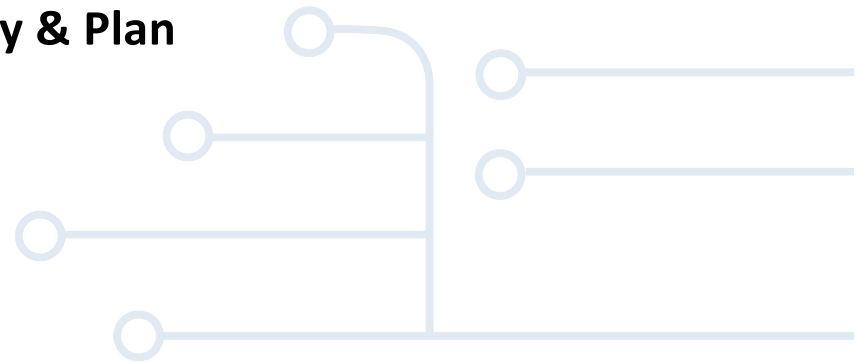
- Incorporation as a Member-based, not-for-profit organization
 - The approval of a Contribution Agreement with the Government of Canada through Innovation, Science and Economic Development Canada (ISED)
 - The establishment of an inclusive, diverse Applicant Board and interim management team
 - A formal process of stakeholder consultation to inform the membership and governance structure, in which more than 210 members of the DRI community participated
 - The development and release of the Governance and Membership Model, including Guiding Principles
 - A call for Primary Members and Associate Members, reaching out to 315 post-secondary institutions, research hospitals, colleges and related organizations across Canada; as of March 31, 2020, NDRIO's membership is composed of 136 organizations and institutions
 - Recruitment and election of an independent Inaugural Board of Directors
 - The first Members' Meeting held in Ottawa, March 2020
 - Work to begin planning the transition of the CARL Portage program by October 1, 2020

 - Dozens of meetings with host sites and regions, transition partners, HQP presentations, and updates to organizations including U15, OCUR and others
 - Board Governance Policies, Committees and Procedures (4 Board meetings)

 - Researcher Advisory Group established and Researcher Council consultations held (110 participants)
 - CEO recruitment in progress
 - Backroom functions in development
 - Additional key staff recruited
 - Funding of RDM activities
 - A clean audit report from external auditors KPMG
 - First Annual Report delivered to ISED

Researcher Council


Researcher Council

- The Researcher Council is essential to establishing a researcher-centric culture of service to, and engagement with, researchers. The Researcher Council will make recommendations to the NDRIO Board and management on the delivery of DRI infrastructure and services.
 - Our By-Laws include the Researcher Council and provide Primary Members with the opportunity to nominate candidates to the Researcher Council, subject to Board approval.
 - Our goal is to have a permanent Researcher Council in place by Fall 2020.
 - A 7-member, multi-disciplinary interim Researcher Advisory Group, led by Dr. Guillaume Bourque, is leading next steps in the formation of the permanent Researcher Council.
 - The Researcher Advisory Group has developed a draft Researcher Council Governance Model, released for community consultation in late June.
 - The Researcher Advisory Group hosted webinar consultation sessions on July 7 (EN) and July 9 (FR).
 - We have had a significant response to our consultations, with over 110 participants in the sessions.

Researcher Council cont'd

- The Researcher Advisory Group will initiate the Researcher Council nomination and application process shortly. Selection will be transparent through an open-posting process and targeted outreach to Member institutions, organizations and researchers. Candidates can be nominated by Primary Members, or they may apply through an open application call.
 - The Researcher Advisory Group will review candidates, with final decisions to be made by the NDRIO Board.
 - The Researcher Council will represent the diversity of the national research enterprise including: research discipline; institution; geographic and linguistic diversity; and diversity between established and emerging researchers. Researcher Council members will have experience in ARC, RS and/or DM domains.

Researcher Council cont'd

- NDRIO is also committed to principles of Equity, Diversity and Inclusion (EDI) throughout the nomination and selection process.
 - We want to ensure that the diversity of researcher voices is represented to the NDRIO Board and management in order to provide guidance on a number of areas, including the researcher-needs assessment and NDRIO's first strategic plan.
 - We ask Primary Members to provide us with a range of candidates, to help us achieve our diversity objectives.
 - The call for applications will begin this week – the **week of July 27, 2020**. Nominations close on **Friday, August 14, 2020**. (Update: the deadline has been extended until **Sunday, August 23, 2020**)

Transition Coordination

Transition Coordination

- Two operational transition plans are being developed.
 1. The transition of Research Data Canada (RDC) / Research Data Management (RDM) and Research Software (RS) with CANARIE – this plan will be prepared by CANARIE in collaboration with NDRIO, to be approved by both Boards before being presented to ISED. **(Planning Deadline: January 2021)**
 2. NDRIO is planning the transition of ARC activities, in collaboration with Compute Canada Federation. **(Planning Deadline: April 2021)**
 - NDRIO and Compute Canada recently formed a Joint Transition Committee.
 - A coordinating committee of Board representatives from NDRIO and Compute Canada has been established to oversee transition activities leading up to April 1, 2022.

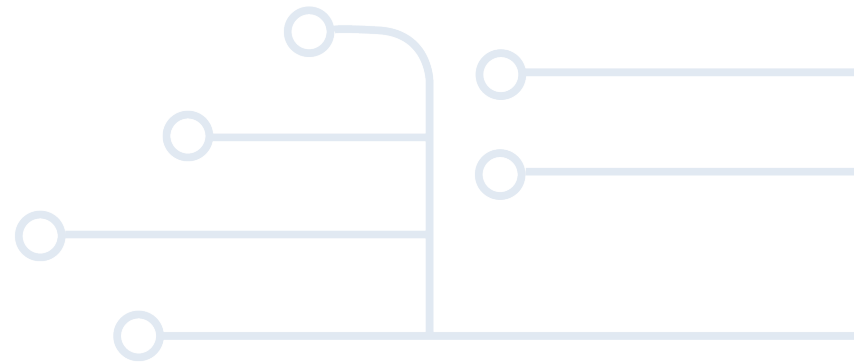

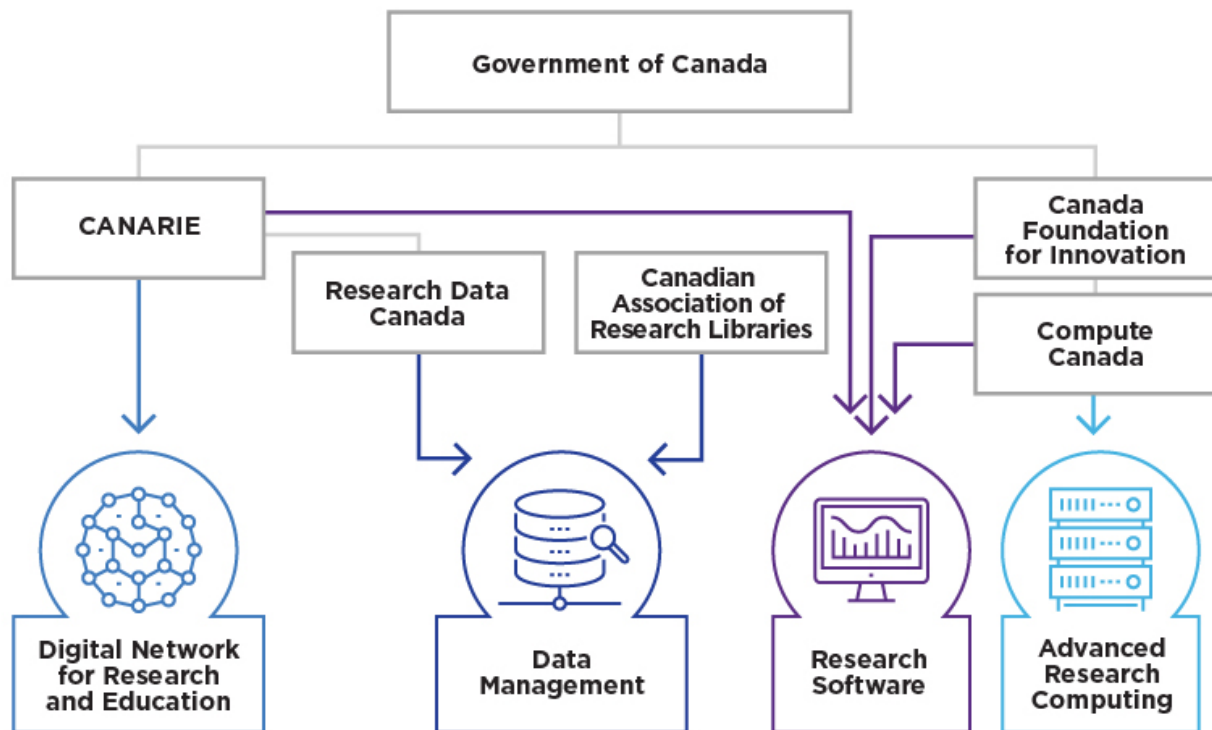

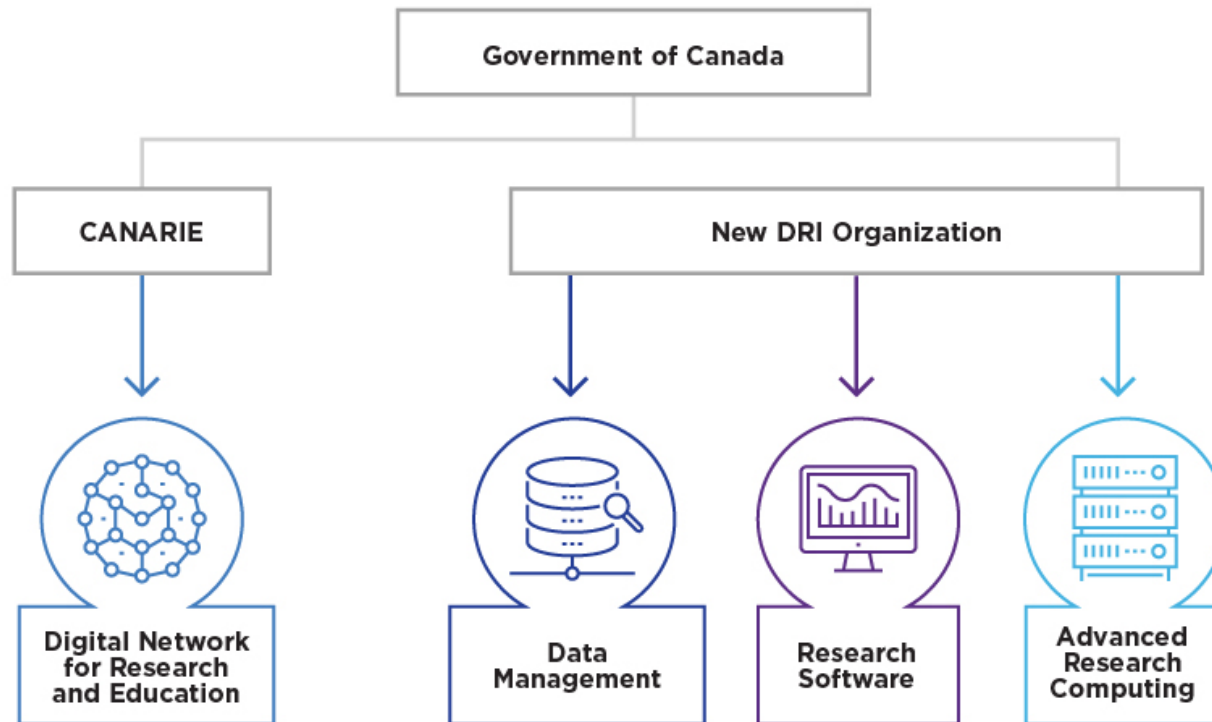

Current National DRI Landscape



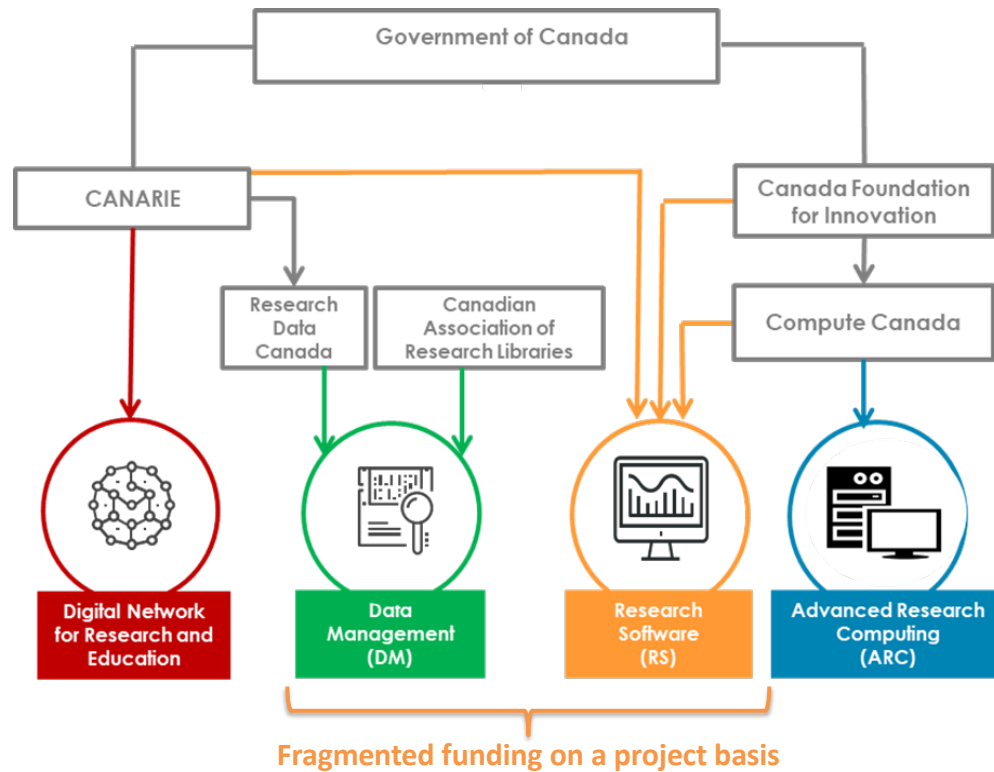
Innovation, Science and Economic Development Canada, 2019

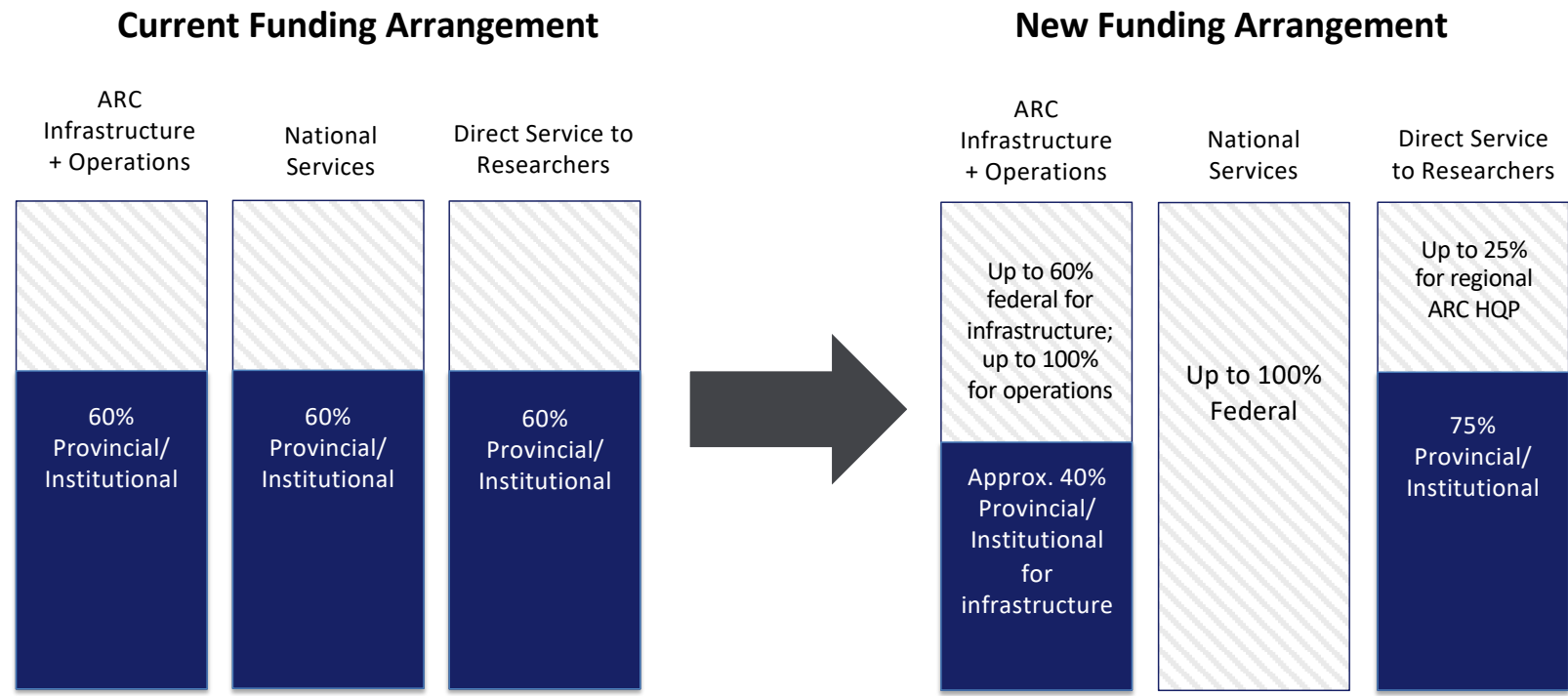
Current National Structure of DRI Ecosystem

Redistribution of Funding Allows for Federal Leadership Nationally

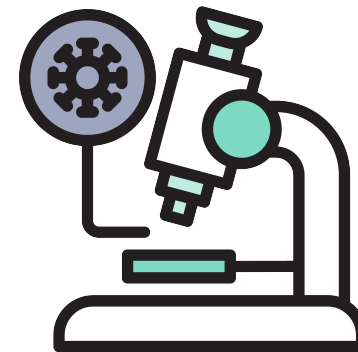

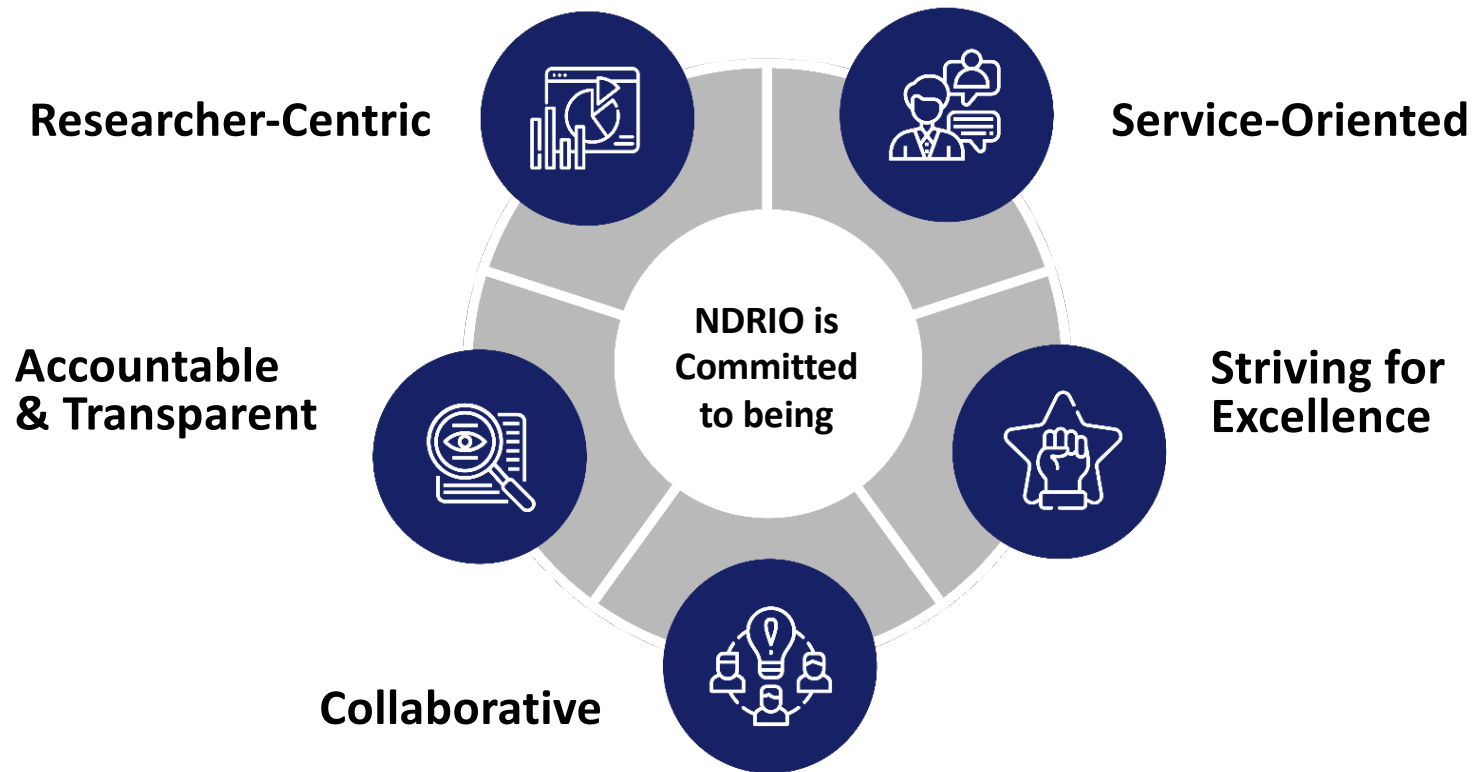
NDRIO Mandate

Equity, Diversity and Inclusion (EDI)

- NDRIO is committed to principles of **Equity, Diversity and Inclusion (EDI)** in its hiring processes and interactions, and respects the rights and dignity of all its staff, Members and stakeholders.
- This is important to the NDRIO Board, management and staff – and we know it is important to our stakeholders including Members, researchers, the DRI community, and the Government of Canada as our funder.

NDRIO Membership

NDRIO Membership

- NDRIO has two categories of membership: **Primary Members** and **Associate Members**.
 - Primary Members (Voting) are post-secondary institutions, research hospitals and/or affiliated institutes eligible for Tri-Council grants.
 - Associate Members include post-secondary institutions that choose not to be voting members and organizations with responsibilities that relate to the national DRI ecosystem.
 - There are currently **136 Members** (as of March 31, 2020).
 - 51 Primary + 85 Associate Members
 - **Membership is not required to access NDRIO programs**, which will be available to eligible researchers and research institutions across Canada.
